- * The group will comply with all laws of the United States, of the State of Michigan and all ordinances and regulations of Inland Township.
- * Written cancellation made more than 14 days prior to rental date will receive 50% deposit.
- * Written cancellation made less than 14 days prior to rental date will forfeit entire deposit.
